### Introduction to RALLY NIPPON 2018 IN CALIFORNIA

We are RALLY NIPPON Foundation, and grateful to host and welcome you to the 10th Rally Nippon

The first ever RALLY NIPPON was hosted in 2009 and the second RALLY NIPPON in 2010, were collaborated officially with UNESCO “Heritage for The Future” movements which started in April of 2009.

From the third RALLY NIPPON in 2011, the event was endorsed and supported by the Ministry of Japan Tourism. The fifth RALLY NIPPON in 2013 took place in Taiwan, in gratitude for donations which we received for Great East Japan Earthquake. The Rally was organized to take a trip around Taiwan. It became the first ever Japanese Rally event to take place abroad.

### 1. Requirements for Registration

To apply for RALLY NIPPON 2018 IN CALIFORNIA, please transfer Entry Fee payments, and mail the following documents and data.

1. Entry Form (Fill-in all the lines.)
2. Color photograph data of the whole participating vehicle  
(Data is not required if you are entering with the same vehicle as before)
3. A copy of participating Vehicle Inspection Certificate  
(Vehicle with a temporary number cannot participate)
4. Copy of Driver / Co-Driver's passport (Face shot page only)
5. Enclosed agreement contract (with signature seal by driver and co-driver)
  - If the documents are inadequate, missing pages or received after the deadline, the application will be denied. The application is approved when the transfer of payments, mailing documents, and transfer of data and completed and received by July 31th, 2018.
  - Depending on the number of applications, RALLY NIPPON, may determine the participants by a lottery system.
  - (Participants from Japan) Vehicle liability insurance and voluntary insurance (optional) can be purchased from RALLY NIPPON, and can be paid with the vehicle shipping fee.

#### Required documents

1. Japanese Drivers license (Participants from Japan)
2. International license that permits driving in the USA

## Application process

### 3. Vehicle Transport Method ▪ Fee (Transporting Vehicle from Japan)

To Ship vehicles, place 2 cars into a 40 feet container and load it from Yokohama Port or Kobe Port. It will take approximately 2 weeks to arrive at Oakland Port. It also requires some time for documentation process, examination, and inspection for exporting and importing of goods. Therefore, we estimate about 3 weeks from the departure to arrival at a storage facility.

Shipping expense includes ① Round-trip ocean freight charge ② Marine Cargo shipping insurance ③ Vehicle liability or voluntary insurance within the United States of America. Insurance fee does differ based on participating vehicles.

I understand and acknowledge the agreements as participants of the rally during the period of RALLY NIPPON 2018 IN CALIFORNIA from October 29th to November 1st, 2018.

1. All participants comply with the road traffic laws as well as related applicable legislation and regulations to drive safely throughout the event in the USA.
2. Must be mentally and physically fit.
3. During the event, if I cause or be involved in an accident as a perpetrator or as a victim (theft or damage of entry vehicle, traffic accident, participants illness or loss of personal items), I will promptly report to the police, fire department, and executive office. I will not imply or attach my form of liability to the host of the event. I will take full responsibility for the matter and settle it on my own.
4. If other participants are unable to make the report to or call the local authorities in an incident of 3., I will act on behalf to make the necessary report or call to the authorities.
5. Before the event (After May 1st, 2018) as well as during the event, I will not claim a refund of fees against decisions made by the host and executive committee. Including canceling or shortening of the event schedule due to natural disaster, concern in the state of society, an act of providence or any cause of attribute by the host party.
6. I will not claim a refund of the entry fee by personal cancellation reason after the application is submitted.
7. I grant the host and related parties to the right and permission to use the movies and photographs taken by event television cameras, filmmakers and cameraman.
8. During the event, I will communicate and interact with other participants, residents, and people in the region of the route in polite and appropriate manners, as well as conduct in ways which does not bring the event into disrepute.
9. I will accept full decisions made by the committee with the setup of operations, and any changes in routes or schedules.
10. Considering all consequence of accidents, I will have third-party liability insurance addition to the liability insurance. In the event of an accident, involving a third-party as well as myself, and or the registered vehicle in damages or injuries, I will take full responsibility and settle them on my own.
11. In the case of violation on terms of agreements, continuing of the event will be decided by executive committee and will comply with the decision made and will not make a further claim against its decision.
